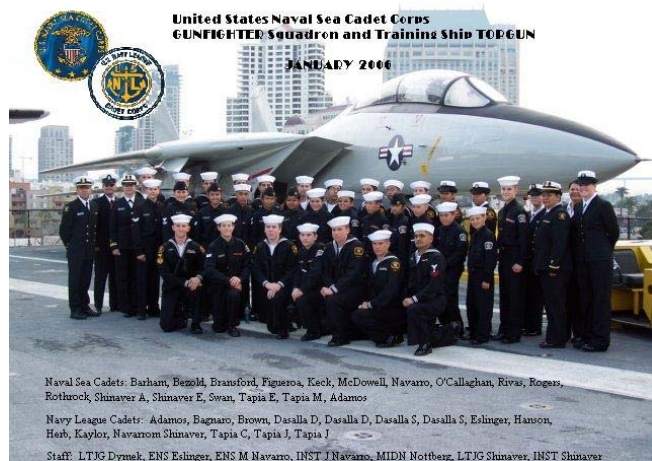

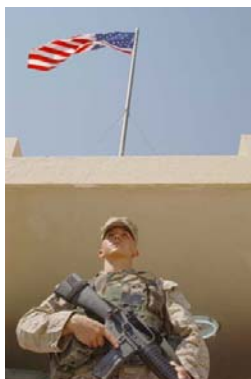


Gunfighter Squadron and Top Gun Training Ship Sea Cadets report:
